1 Accept apologies for absence

5 Appoint Internal Auditor

6. Accounts

Clerk provided details of spend to date, expected year end spend and proposed budget for 2014/15 with comments within appendix 3 of Clerks report. The finance working group had previously met to put a draft budget together. After reviewing the items Councillors resolved to agree to the proposed budget with one alteration. An amount of £500 to be placed in a new fund headed 'Maintenance Infrastructure fund'. This increased the proposed budget to £38,922.00.

Councillors resolved to sign approve the minutes of its meeting on 10th December 2013.

8 Progress reports from working groups

- Traffic/Speed/Pedestrian Safety working group

Updates from the working group had already been included within clerk's report of 14.1.14 under appendix 5 and 6. Councillor Stovold also added that the focus of the group now was to move beyond MVAS and speedwatch. They are planning on using Bucks County Council's repetition system in order to highlight 3 areas, bollards by the post office, Wingrave, speed limit reduction from Wingrave Church to beyond Wingrave school and traffic calming measures for Winslow Road and Leighton Road. The Local Area Forum is likely to have further funding for more MVAS, working group to look into impact on Parish. The LAF is also looking at Centinal a CCTV type recording device in which to record inappropriate driving. Footage would then be passed to police to act upon. It has yet to be approved by police and adopted, however, if it is it is likely that the LAF would provide funding. A demonstration of the equipment is being held on 19th February. Council resolved that Councillor Rickard attend.

- Parking/Road Repairs working group, to include proposals

Council considered the group's recommendations included within clerk's report appendix 4. Councillor Neave confirmed the groups proposals. Council resolved to support all of the proposals made. In edition Macintyre School to be approached to see if their carpark could be used whenever there are events that are likely to create increased parking within the area of Church Street, Wingrave. Clerk raised the possibility of using traffic cones in problem spots when events are happening. Councillor Neave and Clerk to look into feasibility of this.

Councillor Dimmock enquired whether the parking surface could be improved on Moat Lane, Wingrave. Clerk to look into and report back at next meeting.

-Cycle routes/Country footpaths/ Bridleways / Cross country cycle paths working group

Councillor Lynch confirmed that the group is in the process of preparing to meet with Rights of Way representatives to consider removal of some cycling restriction signs. They are also looking to contact land owners in the surrounding areas to explore the possibility of upgrading footpaths. They hope to contact Aston Abbots, Cublington, Crafton and Mentmore Parish Councils to see how working together could create better access for all user groups. The possibility of kissing gates as opposed to stiles is also being looked into. The group are also looking into progressing the recent declined New Homes Bonus application for a cycleway from Wingrave to Bierton. Clerk suggested contacting District Councillor Peter Cooper as he was initially involved.

-Neighbourhood Planning

AVDC has withdrawn the Vale of Aylesbury Plan in light of the recent inspector's report. Councillor Dr Kennedy outlined the key reasons, for ease and fullness of record AVDC's briefing note has been included as additional item to be kept within the minute file. Councillors noted that time pressure to produce a Neighbourhood Plan had eased as a result there remained much work the group would get on with.

-Broadband

It is likely that Wingrave is still on track for faster Broadband in the 3rd quarter of 2014, however, due to type of signal box within Rowsham, Rowsham speed is unlikely to increase dramatically. Further investigations on this by Chris Rawson of Bucks Business First.

20 Bennetts Lane Rowsham. Demolition of existing single storey extension and erection of a two storey side and rear extension. (Amendment to planning permission 12/02753/APP)

Parishioner attended meeting and objected to amended application due to the overall size of the development and loss of light to her property. Councillors discussed application and initially had no objections but agreed to meet at the site on morning of 15.1.14 to review. Councillors agreed that final decision would be made after site visit. Upon site visit Councillors agreed to No Objection to the plans.
